Program Requirements

Completion of at least 6 courses (18.0 credit hours) with cumulative and graduation grade point averages of at least 2.00.

The Post-Bachelor Certificate in Advanced Accounting is composed of six required courses designed to provide a suitable combination of breadth and depth of knowledge in accounting at intermediate and advanced levels.

Minimum Grade Requirement

A minimum grade of 'C-' is required in all courses meeting Post-Bachelor Certificate in Advanced Accounting requirements. Program Length

All Post-Bachelor Certificate in Advanced Accounting requirements must be completed within 5 years after acceptance into the Dhillon School of Business.
