

NOMINATION FORM FOR UNIVERSITY OF LETHBRIDGE Jo and Anne Vanee Memorial Award

This nomination form can be completed by a faculty member (continuing or sessional); staff member; OR, by any continuing undergraduate or graduate student currently enrolled in a Dhillon School of Business program.

To be eligible for this award, a nominee must qualify on the following criteria:

- Returning to full-time studies in the Fall term, following the recipient selection process.
- Academic achievement (minimum of 3.0 GPA) in the previous Fall/Spring terms.
  - NOTE: nominators are not required to know if the nominee meets these two criteria. Rather, submit the requested nomination form and letter, and the Dhillon School of Business awards committee will determine eligibility.
- Demonstrated commitment to compassion, kindness and voluntarism in support of fellow students.
- Nominated by fellow students, staff and/or faculty via submission of this form and a reference letter.

This award of \$1,500 (minimum) will be payable in the Fall term following the granting of the award, upon confirmation of the recipient's full-time enrolment at the University of Lethbridge.

It is the nominator's responsibility to ensure all requested information is included in the submission by the stated deadline, as incomplete or late submissions will not be considered.

#### **GENERAL AWARD CONDITIONS:**

- \* Selection is made by the Dhillon School of Business awards committee.
- \* Unless otherwise stated, to be eligible for awards administered by the University of Lethbridge (see the 'Awards and Scholarships' section in the current Academic Calendar), applicants must maintain continuous, full-time status at the University of Lethbridge in the Fall term immediately following the granting of the award (or Spring term, if selection process is completed during a Fall term). Summer term enrollment only, following the granting of the award, does not meet award criteria.
- \* Normally, awards are payable only at the University of Lethbridge and only for the stated academic year.
- According to Canadian tax regulations, the University of Lethbridge is required to issue T4A slips to award recipients. Therefore; students must provide their Social Insurance Number in order to receive an award (unless attending on an international student visa).
