- Current involvement in agricultural activities or an interest in innovation and/or entrepreneurship in agriculture of agribusiness OR
- Proposal for a project or research in an entrepreneurial endeavour or innovative development in agriculture or agribusiness

This award of \$1,500 is payable upon confirmation of full-time enrolment at the University of Lethbridge in the current semester immediately following the granting of the award. Selection will be by a committee, which will include a faculty member teaching in Agricultural Studies and Student Awards Committee members.

It is your responsibility to ensure that all requested information is attached. **Incomplete or late applications will not be considered.** Scholarships and Student Finance is not responsible for any applications lost in the delivery system.
