Admission Standards Committee Report to General Faculties Council for the Academic Year 2011/2012

1. Mandate:

The powers and duties are as follows:

- a) The Committee shall be governed by the following principles, according to which both admissions of persons to the University as students and transfer credit evaluation are managed:
 - Academic excellence
 - Potential for success in pursuit of academic excellence
 - Identification and consideration of applicants or groups of applicants with special needs or characteristics, who evidence the potential for success in the pursuit of academic studies
 - Fairness, consistency and appropriateness of transfer credit evaluation.
- b) By delegation from Council, to decide on changes in Admission policies, including those reflecting grades, and to report to Council prior to implementation.
- c) By delegation from Council, to decide on changes in credit transfer policies, whether across the University or from another institution, and to report to Council prior to implementation.
- d) To make decisions regarding the admission of students under these principles in the light of institutional capacities, resources, and other factors which may be appropriate to consider.
- e) To make decisions regarding transfer evaluation in a manner consistent with these principles.
- f) To serve as a policy and advisory body for the Vice-President (Academic) for matters relating to the Campus Alberta Quality Council.
- g) To report to Council as required but not less than once a year.

The Registrar shall be responsible for appointing a Secretary to the Committee.

2. Meetings

During the 2011/2012 academic year, the Admission Standards Committee (ASC) met on: 11 October 2011, 8 November 2011, 29 November 2011, and 18 April 2012. Email votes were held on 1 December 2011, 9 December 2011, 12 December 2011 and 16 March 2012.

3. Policy actions

The ASC routinely decides on matters arising from changes in the environment (e.g. new secondary curriculums throughout the western provinces) and new University curriculum. Full details on ASC agendas, decisions and policy documents can be found through the ASC links on the GFC website at,

Items of particular interest from 2011/2012 include:

a) Minimum graduate level international admission requirements were established for the 116 countries. (ASC, 11 October 2011, 8 November 2011, 29 November 2011)

- b) Admission routes available to Faculty of Management applicants were revised to include direct entry from high school. (ASC, 11 October 2011)
- c) Admission requirements to the Bachelor of Health Sciences program with a major in Aboriginal Health were established. (ASC, 8 November 2011)

4. Sub-Committees

- a. The Admission Standards Steering Committee (ASSC), comprised primarily of Faculty/School representatives, meets more frequently than the greater Committee, in order to select items for the ASC agenda.
- b. The Enrolment Tracking Committee (ETC), comprised in similar manner to the ASSC but with Institutional Analysis representation, continued to operate under the Strategic Enrolment Management Committee (SEMC) umbrella.
