3. PRESIDENT'S REPORT

M. Mahon reported:

• United Way

Catherine Ponomar, Community Development Manager for the United Way, was welcomed to the meeting and thanked for her ongoing support and efforts. --C. Ponomar was present as a reminder of the ongoing partnership the U of L has

with the United Way of Lethbridge and Southern Alberta.

--Last year, due to increased encouragement, faculty and staff raised just over \$7,500 which goes directly into our community.

--There is some information available on which organizations were funded last year from the United Way's Community Fund and it is an impressive list.

Organizations such as Big Brothers and Big Sisters, the Interfaith Food Bank, OpoKaa'sin Early Intervention Society, Woods Homes and the YWCA, to name just a few.

--There is a website that you can visit to either make a contribution or set up payroll deductions and people were encourage to take a look at the information this year. --Payroll donation forms need to be in by Christmas but you can do one-time donations any time.

-- Thanks was given to all those who have donated in the past.

- The Associate Vice-President (Research) appointment was approved by the Board of Governors on Thursday, December 10th. Dr. Claudia Malacrida will commence her appointment on January 1, 2016.
- People Plan 2016-2019 was also approved by the Board of Governors on Thursday, December 10th. It is the first People Plan for the U of L and one of just a handful of People Plans in existence at universities across the country. The People Plan committee attended to provide the Board with an overview of the Plan.
- A Banner Revitalization project update will occur at the next GFC meeting.
- Congratulations was given to Lisa Doolittle who received the 2015 Award in Excellence in Education presented by the Alberta Premier's Council on the Status of Persons with Disabilities.
- Government meetings:

--We are continuing to push ahead on the Destination project. Meetings were held with the Deputy Minister of Infrastructure and our Deputy Minister. --He participated with Team Lethbridge in Edmonton, along with Erasmus Okine and Richard Westlund. Time was spent with a variety of ministers, deputy ministers and chiefs of staff. The theme of the meeting is to help the government at all levels understand what is going on in Lethbridge.

- Legislation on Essential Services and Labour Relations Model --There is a lot of activity regarding the right to strike for Faculty Associations. We have provided feedback to the province, which is quite similar across institutions. There is strong consensus on trying to maintain the essence of any changes within the context of the Post-Secondary Learning Act, rather than taking it outside of the Act.
- He met with City officials on Friday, December 11th.
 --The U of L senior team recently attended a retreat with the City of Lethbridge

senior team. This provides a great opportunity for both groups to enhance collaboration and look at strategic directions.

- Thanks to Dr. Ian MacLachlan for serving as Chair of GFC Academic Quality Assurance Committee and special recognition was given to him at his last GFC meeting prior to retirement! Ian has been an instrumental member of GFC who has been involved in numerous GFC Bylaw revisions, the student assessment of learning policy and even the convocation invocation before us today. It was interesting to note that at Ian's last class there were quite a few regalia-clad visitors!
 - The new Chair of GFC Academic Quality Assurance Committee is Alan Siaroff.
- Launched at the annual Volunteer Fair, a new initiative called "**UVolunteer**" sets in motion an action plan and database that coordinates all the student volunteer activity on campus, in partnership with Volunteer Lethbridge. This will be housed under the Liberal Education revitalization.
- He recently chaired the Council of Western Canadian University President's meeting in BC. There was rousing discussion around a lot of things going on in western Canada at the post-secondary level.
- The dedication of the NAS Lounge space in honor of Narcisse Blood, who tragically passed away in Saskatchewan, was held on November 17. There was a large number of family, friends and faculty at the naming ceremony.
- He attended the UofS Building Reconciliation Leadership Forum on Truth and Reconciliation on November 18th and 19th as a member of the President's panel. Representatives from 50 Canadian universities were in attendance.
- The University Christmas Reception will be held on December 17 at 3 pm in the Atrium.
- Congratulations to Anne Dymond and the faculty and staff serving on the UofL Syrian Refugee Action Committee. They have raised over \$26,000 to re-unite a family in Lethbridge. Please watch for upcoming activities from this group.

4. **QUESTION PERIOD**

- D. Olsen asked about the review of the Post-Secondary Learning Act as there is nothing yet on draft legislation. M. Mahon said they've heard nothing to date but there are 2 elements being considered. 1) Possible changes in legislation regarding the right to strike and 2) a review of the system that may result in changes to the PSLA.
- E. Jurkowski asked about the date for a new board chair. M. Mahon said they are still waiting and in the meantime, are transitioning with Acting Chair, Richard Masson, and Vice-Chair, Patrick Forrest.
- I. MacLachlan expressed concern about the problem with student attrition, which is something faculty see at this time of year. He wondered what kind of progress has been made on retention to try to deal with these issues. M. Mahon turned it over to A. Hakin, who responded that the U of L has seen the highest retention increase of 3.6% overall, putting us at a new high school retention rate of over 80 %. the highest ever at the U of L. This is a result of many years of activity and supportive programs for students, including mentorship (internal and external), supported by our AVP (Students) office and Counselling Services. As well, our faculty colleagues have been taking an increased interest, especially at the introductory level, so we hope to see

continued improvement. Thanks to everyone for their efforts in supporting our students.

Sheila McManus, Convocation Chief Marshal, attended the meeting to speak about the new Reflection, which has been approved by the Convocation Committee. The goal had been to update and modernize the verse as well as improve language and flow.

It was explained that the working group found "Invocation" definitions to be about religion and magic spells, while "Reflection" better represents what we are asking of our grads and also pairs with a pledge that they read together at the orientation ceremonies.

There was a question about the Fiat Lux pronunciation (Fee-at Looks) being included in the text. S, McManus clarified that it is only included on the version for grads in order to assist them in the reading, but is not published. There was some discussion about the decision to change it, wanting to have it remain as invocation as well as comments regarding preference between the two versions.

6. ITEMS FOR INFORMATION

6.1. Destination Project

A. Hakin reported that Brian Sullivan and his team have relocated to the ATCO trailers north of Markin Hall. They have received reports which provide an overview on 1) wind interference (with mitigation strategies), 2) snow moving and drifting, and 3) exhaust and smoke containment. These studies were completed with a group at the University of Guelph. They will be shovel ready in May/June next year.

6.2. Fundraising Presentation

C. Horbachewski, Vice President (Advancement), gave a high-level presentation on the U of L framework of fundraising, the purpose being to initiate conversation around fundraising because as we are in a quiet campaign. In the future another presentation will be provided to GFC as a Part II.

The key terms of philanthropy, advancement and development were defined. In regards to why people give? Statistics Canada (2010) reports that the majority of donors give because they feel compassion towards people in need. At the U of L, it's because donors believe in our vision. They trust the U of L; they have an affiliation. Sometimes they want recognition (which is rare) and in those cases, the issue comes up late in the conversation.

Where do the Gifts Come From?

A 2013 U.S. study shows that the great majority (72%) of gifts come from individuals, and that is the case at the U of L. It was noted that the majority of our over 40,000 alumni are now in their 50s and that typically, most people don't start giving until they are in their 50s.

Where do People Give?

In 2010, there was about \$10.6 billion worth of charitable gifts made in Canada. Of that, 3% went to Education and Research, 1% to universities and colleges. The highest percentage (40%) went to religious organizations and after that, to Health.

The U of L Development Programs were defined: Planned Giving Program; Major Gifts; and SOS, Direct Mail, Student Call Centre.

What Guides us at the U of L?

Major Gift Processes

--Strategy and Proposal

--Naming and Recognition

--Establishment of new academic programs

--Acceptance of Gifts/Refusal of Gifts

Faculty Handbook

--The common good of society depends upon the search for truth and its free exposition. Academic freedom in both teaching and research is essential to these purposes. Members are entitled to the freedom to carry out research and to publish the results, to the freedom to teach and discuss their subjects, and to the freedom from institutional censorship. Academic freedom carries with it the duty to use that freedom in a responsible way.

Gift Agreements

--The University shall operate in accordance with the PSLA of Alberta, with the mandate approved by the Minister of Advanced Education, with academic processes approved by the General Faculties Council, and the academic freedom of its faculty members shall be maintained to the fullest extent.

Governance and Accountability

--Major Gift Process, Faculty Handbook, Gift Agreements, U of L Board Policies and Guidelines (Fundraising Coordination Policy, Naming Policy, Gift Acceptance guidelines, Donor Recognition and Stewardship guidelines, Prospect Management and Clearance guidelines).

There was a question about the sources of U of L gifts. They are mostly cash donations, but some donors, such as Jim Coutts, gift considerable personal assets. As well, quite often the Advancement office will get a call from a law office regarding the disposition of an estate where the U of L is one of the beneficiaries.

Advancement is currently working on changing to a new online giving tool that would give us the ability to link to faculty pages and social media. It was also noted that an additional purpose of the presentation was to enhance transparency. Everyone was encouraged to provide feedback and advice in order to help bring in more resources.
