- Maclean's Ranking was revealed 2 weeks ago
 - for the 5th consecutive year, UofL has landed in the top-three spots for Canada's best Primarily Undergraduate university
 - o UofL was ranked the top (tied) university in the Student Services category
 - o we ranked second in Medical/Science Grants
- Re\$earch InfoSource
 - o for the second consecutive year, the UofL has increased is ranking among the country's elite research universities, moving up one spot in each of the undergraduate (moved to 3rd) and overall (34th) categories

6. ITEMS FOR INFORMATION

6.1. Destination Project

A. Hakin introduced M. Letts, Academic Project Manager, who will now update the committee on the progress of the Destination Project. M. Letts will work with B. Sullivan on the project. We are about a month ahead of schedule. The concrete has been poured on the 6th floor with pillars, elevator shafts, foundation walls erected. They will be starting the piles for the link to University Hall. The second tower crane is to be set up this week if the winds slow down. The vivarium plans have been finalized. Underground piping is being laid on the north end for the vivarium and sometime in the next month or so, the floor will be created. The design teams are working hard to keep up with construction as they are ahead of schedule. Our goals go beyond the physical construction of the building – we want to promote a generic flexible building to serve the needs of the university for the next fifty years. There will be a need for a new position of a science and academic building facility manager. This position will develop timelines for occupancy when the building nears completion as well as developing policies and operational procedures. Some questions and discussion occurred on how the building is impacting the community and the impact on users in relation to design quality. It was mentioned that properties being bought in the Lethbridge area have gone up 3% which has been attributed to the Destination Project, and items like the concrete and rebar are being purchased locally. Regarding the impact to users, researchers have been aware of this for three years already and we want to move people in slowly as to not disrupt research. There will be some pain in the move but we hope to minimize it. Concern on the status of the communication of ideas that faculty has inputted was discussed. M. Letts stated that not much has changed in design in the last 8

months. A. Hakin mentioned that for design they are working on the floor that the construction team is working on. The other floors will be tackled as construction moves along and the researchers will be consulted if changes are made to the design. M. Letts was asked how many classrooms will be in the building. An exact number was not given. It was mentioned that Concordia has moveable classrooms which D Hinger is going to look at in the near future.

6.2. Academic Quality Assurance Committee Update

A. Siaroff, Chair of the GFC Academic Quality Assurance Committee reported on the activities of the committee. The updates and progress were laid out in the agenda package. A couple of reviews are delayed and Dean Cooper is to help prod those departments. The committee will be undertaking its own review on their internal processes next year.

6.3. Banner Revitalization Update

C. Nicol, University Librarian and S. Kennedy, Registrar gave a presentation on the Banner Revitalization project. Version 1.0 wasn't available until the beginning of September to be tested. As we are ruled by the regular academic cycle, we are delaying the implementation so it will be as smooth as possible. Some implications to General Faculties Council are with motions that we have passed. There is a curriculum freeze to work with the new timeline of implementation. The freeze on new programs and changes in majors/minors have been delayed until May 1, 2018 and implemented in the 2018/19 calendar. We are also postponing implementation of new admission requirements to the 2018-19 calendar. We are working with Enrolment Services to get that information out to future students. A. Hakin stated that there has been a tremendous effort to get our enterprise system so we are back in control. It is all about risk modification.
