3. PRESIDENT'S REPORT

3.1 Donor Recognition Wall Unveiling

Bill Cade reminded the Board of the Donor recognition wall unveiling to take place in the LINC foyer on November 26 at 7:30 p.m. Aside from the recognition of the numerous donors, one section has been set aside to recognize the great number of students who have contributed to the LINC campaign. Bill Cade encouraged all the Board members to attend the event.

3.2 News Articles

Bill Cade referred to the news articles included in the agenda that address the issues facing the University of Calgary and Mount Royal College.

3.3 University of Alberta

The University of Alberta has named their 12th President, Dr. Indira Samarasekera. A letter of congratulations has been sent to Dr. Samarasekera.

3.4 MACLEAN'S Magazine

Bill Cade reviewed the latest MACLEAN'S rankings, and mentioned that the University of Lethbridge did reasonably well. High scores were received in a number of categories, including a second place finish in the country for the scientific and medical research areas. The University improved in the class size ranking. One area that is still weak is alumni support, but there is anticipation that this will improve over time since being a young institution has an impact on

alumni support. A MACLEAN'S graduate survey was also completed in which the University of Lethbridge did exceptionally well. 70% of graduates said they had a very good overall graduate experience at the University of Lethbridge. Bill Cade mentioned that the University of Calgary was at the bottom of this list, although their President feels that their overall student satisfaction is higher than what shows in this survey. The Board was reminded that the differences in places is minuscule, and that all Canadian universities are good schools. Linda Anderson mentioned that she was a responder to the graduate survey.

Bob Turner referred to the article in the Globe on Tuesday concerning ranking of U.S. business schools. Some were dissatisfied with their ranking and have opted to not participate fully.

Bill Cade explained that entering grades continue to be an issue for us in Alberta. Over half of the students graduating in Ontario have averages of 80% or greater, as a result of grade inflation, which MACLEAN'S does not take into account. Bill Cade noted that one of the hallmarks of the University of Lethbridge is that we are an accessible university.

It was also mentioned that in the internationalization of universities article, it said to truly be great, universities have to reach out and have international students. The University of Lethbridge has jumped in its rating for percentage of international students. The Board authorized goal of 7% has been exceeded and is now at 9.4% of incoming students.

5.1 General Liberal Education Requirement

Following a multi-year review by a cross-University committee of General Faculties Council (GFC), GFC approved in principle a new model for the General Liberal Education Requirement (GLER) component of all 4-year degree

Although it will take some time to adapt it for other models (combined degrees and post-diploma) and to work out implementation details, this represents a major step forward in the evolution of curriculum. Among the important new features are writing and numeracy requirements in all degree programs.

5.2 Registration

Registration for the Spring 2005 semester is under way, and full on-line registration is available to all students. More than 75% of all course registrations are being done through the Web.

5.3 **Spring Enrolment**

Applications and admissions activity suggests that the number of new students registering for January 2005 will be very close to the level of January 2004.

Maude Barlow, Chairperson for the Council of Canadians, will be speaking in the Students' Union ballrooms on November 29. The topics include the international movement of the Council of Canadians and water issues.
