# A. RESEARCH CENTRE/INSTITUTE PURPOSE

The Centre for the Study of Scholarly Communication (CSSC) is a centre for education, discussion, and research around the issue of scholarly communication at the U of L and universally. As such, its goals include: supporting research around new forms of scholarly communication; supporting the dissemination of new research through open access venues; supporting scholar-editors and authors in their work within the scholarly communication ecosystem; offering training to graduate and undergraduate students, as well as post-graduates and faculty; and providing librarians and other researchers with a context within which to study various forms of scholarly communication in practice.

In order to accomplish these goals, the CSSC has planned and implemented programming in the form of workshops, panel discussions, and talks throughout the year. These were educational to all members of the U of L community in attendance, and they helped initiate further conversation, thinking, and research into current and relevant scholarly communication topics. The CSSC was also involved in the initiation and planning of the first annual Force11 Scholarly Communication Institute, which took place this summer at the University of California – San Diego.

Additionally, the Journal Incubator has continued work in training U of L students through the editing and production of open access scholarly journals. A mark of success for the Journal Incubator's journals is the fact that two of the journals were accepted into the Open Library of the Humanities in the past year.

Besides programming and the Journal Incubator, the CSSC has contributed to campus resources such as the Institutional Repository and research guides that are available to all U of L researchers and to the world at large – through the Institutional Repository we make U of L research openly available and accessible to researchers worldwide.

Finally, members of the CSSC have contributed research in the form of publications, lectures, and presentations throughout the year.

We began the process of revising the repository policy and rebranding it, and explored options to maximize its usage by U of L researchers; new name selected by university-wide poll is **OPUS** (Open ULeth Scholarship).

Collectively, the CSSC members have increased the Centre's capacity for research and education in issues around data management, copyright, open access publishing, and other scholarly communication issues, thereby increasing the U of L's capacity in these areas. Through sharing knowledge and collaboration within the Centre and outreach efforts beyond the Centre, we have identified the most relevant research and training issues to focus on.
