2. PRESIDENT'S REPORT

M. Mahon reported on the following:

- Chancellor Announcement Terry Whitehead (BA '94), one of the University of Lethbridge's most engaged and impassioned alumni, has been elected by the ULethbridge Senate as the institution's 15th chancellor. Thank you to GFC Members of that Search Committee.
- Federal Budget- came down last week, not much support regarding post-secondary institutions.
- Provost Search as indicated at last GFC the committee has now met and consultation has commenced thank you in advance for your participation in this process. Please participate in the consultation process.
- Budget and Staffing Information good news story about budget, this is the first year we can start reinvesting in full time continuing funding for approximately 50 positions. Increase to compensation to non-bargaining groups has been approved by the government. This group has been frozen for approx. 6 7 years. The budget will come to GFC in May.
- People Plan is being renewed A People Plan Advisory Working Group has been established to renew the University's People Plan.
- Signing of the Buffalo Treaty UL signed as a supporter of the treaty as part of ULethbridge's annual Indigenous Awareness Week activities.
- Dean Faculty of Health Sciences Congratulations to Dr. Jon Doan (PhD '06), whose work has focused on improving the lives of those affected by disease and disability, has been appointed dean of the Faculty of Health Sciences. We know there is ongoing confidential work in three other searches so look forward to those outcomes as well.
- Donor Gala well attended; celebrated our donors and the impact they have on our students by helping to remove financial barriers to education. Not just a celebration of external members but internal members of our community as well.

5. ITEMS FOR INFORMATION

5.1. CCC Update – Online Campus

From a question that arose at last GFC, N. Buis-Deering reported that we have 4 active campuses: other - off campus work/field experience, practicum etc.; Calgary; Lethbridge; and online. In 2017 the Bachelor of Therapeutic Recreation implemented an option for admission to the exclusively online delivery program. As this was the first entirely online program option, it required in 2018/2019 an online campus to be administratively created. Fees and government reporting all require this tracking. Some questions arose on what types of fees are exempt and clarity was given that this program is required to be exclusively online so it is not just some online course options.

5.2. GFC Nominations Committee – Call for Nominations

D. Scott said there are 20 vacancies on 7 committees. They are 2-year terms to be filled by Academic staff members, all information is contained in the agenda package. Please consider yourself or a colleague to help fill these openings.

In all instances of future use of the PowerPoint or other places where the data will be shared, the following note will be included on every slide: This data is preliminary and is not based on a representative sample, it reflects the responses of the 664 people who completed the survey (response rate = 31.9%).
