C. Hosgood provided rationale for factoring in CASPer scores for admission rather than GPA alone and the benefit that this will have for students and the University. It was highlighted that this is only a pilot project to measure the change and impact of these scores, specifically in the number of applications and would this help more students gain admission to our programs. It was mentioned about other schools using these scores and how we would be matching their admission standards. Question arose on historically marginalized groups and it was noted the priority for ensuring access, and it is not a standardized test, but rather a situation leadership test and equity deserving groups don't fare worse on these kinds of tests, compared to standardized tests. Equitable access is a priority for the faculty.

At this point in the meeting a procedural concern was raised with report 2 – recommendation two "That GFC approve new program admission requirements for the Dual Degree Bachelor of Arts/Bachelor of Laws in conjunction with Bond University for implementation on September 1, 2023." and the resolution by the chair and member was to bundle the recommendation with recommendation #22 from GFC CCC Report #1. M. Letts discussed the rationale for this motion. There is no LSAT test at Bond University, in Australia. This provides a pathway for students to peruse a law degree at the University of Lethbridge. It was highlighted that other institutions also have similar arrangements with universities in the United Kingdom.

Significant discussion occurred on this item. It was clarified as a dual degree program and that the focus of study is Canadian Law. This program is designed to be a pathway back to Canadian law.

They will be only admitting domestic students to this program to start with potentially opening to international students later. This is an international partnership and that this partnership aids in our institutional goal of increasing internationalization. It was noted that we have not yet approved courses yet as we need to approve the program before we can approve the courses. The resource implications are not yet known for these courses but would be required at year 5 of the program. The Faculty of Arts and Science has approved the offering of these courses, pending the appropriate GFC approvals.

It was also asked if it was possible for students to go to Bond and enrolling in another type of law program that Bond offers, rather than Canadian Law. We are only approving the dual degree concept and that Arts and Science Academic Advising, and the Student Enrolment and Registrars Services (SEARS) will put tighter Program Planning Guides and resource tools to help guide students on the best pathways for their needs. It was also highlighted that these programs are highly nuanced and requires study permits and preparation before the first day of classes here at our institution. Students highlighted that students have the ability to make their own independent choices, in terms of what they study, and they should get to make the choice of what they want to study.
