# **Bi-Cameral Governance**

The University of Lethbridge governs itself with a bi-cameral structure, as set out in the Alberta <u>Post-Secondary Learning Act</u>. The <u>Board of Governors</u> has authority for business governance and the <u>General Faculties Council</u> (GFC) has authority for academic governance. The <u>Senate</u> is defined within the Post-Secondary Learning Act as having the authority to elect the Chancellor, approve honourary degrees, and it is the duty of a Senate to inquire into any matter that might benefit the University and enhance its position in the community.

# President & Vice-Chancellor

### Dr. Digvir Jayas

The President has general supervision over and direction of the operation of the University [Post-Secondary Learning Act (PSLA), Section 81 (3)]. The President provides leadership to generate and sustain an academic and administrative vision of what the University should be that optimizes the development of the University. The President ensures the University's objectives are achieved and the University's quality and future is assured. The President is responsible for carrying out all of the duties required in the capacity as President & Vice-Chancellor with General Faculties Council (GFC), the Senate, the University of Lethbridge Faculty Association, other employee groups and the general public, as well as working closely with the Board of Governors. The President's primary responsibility is to lead the University in an ethical, responsible, sustainable manner.

# Provost & Vice-President (Academic)

Reporting directly to the President, the Provost and Vice-President (Academic) is the senior vicepresident. The Provost is the Chief Operating Officer and the Chief Academic Officer of the University of Lethbridge and acts as the President's delegate as required. As Chief Operating Officer, the position is responsible for institutional planning and administration in all aspects of the academic operations involving students, academic and support staff, alumni, members of the governance committees, and staff associations. As the Chief Academic Officer, the position leads the conceptualization, development, implementation, and continuous improvement of academic programs and services. As senior Vice-President, the Provost co-leads, with the President, a team of Vice-Presidents, as well as a senior management team including Deans and senior administrative officers. The provost is responsible for providing leadership, oversight, and direction across a broad spectrum of University operations including: institutional planning and administration in all aspects of university operations academic program maintenance, development, implementation, and quality assurance enrolment management and student support services resource allocation budgeting and reporting in collaboration with the Vice-President (Finance and Administration)

Through strategic planning and prioritization, they drive an integrated approach in collaborating efforts with the marketing and communications teams..

Working with the University community, the Vice-President (External Relations) is responsible for designing and implementing comprehensive institutional fund development, alumni and community programs to increase constituent engagement. They mobilize an engaged Board of Governors, President and other senior leadership to achieve uLethbridge's fundraising goals.
