2. PRESIDENT'S REPORT

- D. Jayas reported on the following:
 - Fall Semester Kick Off; September 6th First Day We did NSO on both Lethbridge and Calgary campuses which were hugely successful.
 - Fall 2023 Enrolment total enrolment forecast is currently 8,391 students; this is a 1.5% increase from the prior Fall enrolment of 8,263 students.
 - South Campus Development the first step to the development is the incorporation of the University of Lethbridge Business Corporation
 - Susan Dieleman named Jarislowsky Chair in Trust and Political Leadership
 - Horn's Triple Header Event Saturday September 16th the President invited everyone to attend.
 - Campus Welcome Walk D. Jayas thanked the participants who walked with him. It was a warm welcome to campus.
 - Successful Provost search with the recent appointment of Dr. M. Helstein as the new Provost & Vice-President Academic effective September 1st with Dr. C. Hosgood appointed as Interim Deputy Provost.
 - As noted within the agenda today for staffing the committees from GFC, the search committees are being formed for the Deputy Provost position and for the Vice-President (Finance & Administration) position.
 - Tour of Agri-Food innovation Hub and grand opening of new building. He encouraged all to check it out.
 - Attended his first Calgary Stampede events including Premier's Breakfast. It was the first time he wore jeans! It was a great event. He was able to give ribbons to a youth event that the UofL sponsored.
 - Tour of Haul All with donor and Board member Kelly Philipp.
 - Campus tour with Sport & Recreation Services
 - Meet and greet with School of Grad Studies
 - Campus visit of Red Crow Community College we are exploring options to deliver more courses at Red Crow.
 - Post-secondary pancake breakfast was a joint UofL & LC event for Whoop Up Days.
 - Visit with the Federal Minister of Jobs & Economy, Matt Jones, on campus. He was able to tour the trading center.
 - Attended a reception with Advanced Education Minister Rajan Sawhney in Calgary
 - Local food processing tour with MP Rachael Thomas of three different processing plants to see how we can enhance our course offerings.
 - A new institutional strategic vision and plan is needed to address the changing landscape of post-secondary education both nationally and globally, and to respond to the evolving opportunities and challenges for the University of Lethbridge. Along with this overall strategic planning a renewal of our Academic Plan, Research Plan, and People Plan are also required. To this end, individuals from the Strategic Planning Committee, the Provost's Office (Academic Plan), ORIS Office (Research Plan), and the University community will be embedded in the planning process to ensure

engagement activities, and subsequent drafting of respective plans, to properly reflect the information gathered. The engagement process will commence this Fall. Single feedback process for all plans and then using the feedback to develop all of the plans. The Calgary campus will also be involved in the process.

- ULethbridge has completed a dose response study in rodents for GB Sciences, Inc., a leading cannabis- and plant-inspired biopharmaceutical research and development company.
- Dr. Jenny McCune, a biology professor, collaborated with an up-and-coming filmmaker, alumnus Rodrigo Henriquez (BFA New Media '20) to produce a documentary designed to focus greater public attention on endangered plant species and her fight to save them.
- University of Lethbridge researchers across a breadth of disciplines have earned more than \$2.3 million in funding support from the Natural Sciences and Engineering Research Council of Canada (NSERC) and the Canada Foundation for Innovation (CFI)
- Three ULethbridge Researchers named Canada Research Chairs; Stacey Wetmore, Trushar Patel, and Julie Young
- Dr. Michael Gerken, a professor in the Department of Chemistry & Biochemistry, was recently named a Fellow of the American Chemical Society (ACS), an honour currently shared by only seven other Canadians.
- Campaign for Students is gaining momentum and enthusiasm as donors actively seek to enhance their philanthropic contributions through our matching program. By prioritizing our students and their award needs, we have witnessed the development of new awards, the conversion of annual awards into endowed ones, and a notable rise in donations to existing endowed awards.
