¹ Students are required to pay a Term Fee for each term they are in the program over a period of four years (minimum of twelve term fees; twelve term fees cover up to six instructional course equivalents). Students who have completed twelve terms will then pay a Continuation Fee each term until they complete or withdraw from the program. Six-week SGS Thesis Courses are assessed tuition as a 1.5 credit, graduate level course plus applicable fees. Registration would be by School of Graduate Studies approval only.

² The Student Administrative Fees include the Student Services Fee of \$51.74, Student Copyright Access fee of \$3.15 and Technology fee of \$5.39 per course. The First Twelve terms are calculated to spread Ph.D. cumulative fees evenly over this time period (four-year program). The Continuation Service Fee is based on a per course rate.

³ Fine Arts Access Fee (only assessed in Fall and Winter) - To give Undergraduates and Graduates free admission to all ticketed Fine Arts events on a first come-first serve basis.
