It is the NESA BN Programs student responsibility to disclose any family member or relative relationship to the Assistant Dean of Nursing (University of Lethbridge), where the student is completing their preceptorship, <b>PRIOR</b> to the preceptorship commencement. Any potential conflicts	
	of interest will be assessed on a case-by-case basis by the Assistant Dean of Nursing (University of Lethbridge).	
3.	Students <b>CANNOT</b> be precepted or assessed and evaluated by a family member or relative.
