Course Description:

This course is designed to give senior students the opportunity to learn about the process of conducting primary research in a step-by-step fashion. To that end, each class will focus on a specific aspect of the research process (e.g., forming a testable hypothesis; picking a research design; understanding data analysis), and will consist of hands-on, in-class activities and out-of-class assignments. Students should note that this is NOT a lecture-based course. The course is not suitable for students who cannot commit to attending every class and to spending a significant amount of time each week outside of class working on assignments and assigned readings.

Prerequisite Courses and Background Preparation:

The prerequisites for this course are Psychology 2030 AND four (4) additional courses (12.0 credit hours) in Psychology or Neuroscience (including two at the 3000-level), AND 4th year standing (a minimum of 90.0 credit hours completed). With respect to 3000-level courses, it is strongly recommended that students have one course in Psychology (3.0 credit hours; designated Social Science), and one course in Psychology or Neuroscience (3.0 credit hours; designated Science). Students who do not have the required prerequisite courses (e.g., verified transfer credits) may be deregistered from the course without warning. In exceptional circumstances, a prerequisite waiver will be considered for a student who has adequate equivalent background. If you are considering requesting a waiver, please contact your instructors prior to the end of the add/drop period. Submitting a request for a waiver does not guarantee that you will receive one; each case will be evaluated individually, and you will have to provide supporting documentation for prior courses not taken at the U of L. At the 4000-level, students are expected to have a broad range of knowledge of the fundamentals of psychology and neuroscience; prerequisite courses are considered the minimum background preparation for this course.

Course Rules and Regulations:

You are expected to attend and arrive on time for every class. Course Requirements:

(1) Quizzes (30% total). At the beginning of class (3:05 to 3:20 pm), students will write a short quiz consisting of conceptual multiple-choice questions based upon the assigned readings for that class. With the exception of extenuating circumstances (see below), students who arrive after 3:15 pm will not be permitted to write the quiz and a grade of 0 (zero) will be recorded. There will be a total of ten (10) quizzes. The average of your marks on these ten quizzes will count for 30% of your final grade.

Penalty: Students who fail to achieve a passing grade after the first 6 quizzes in the course forfeit the opportunity to write the remaining quizzes for course credit. In other words, only your first 6 quizzes will account for 30% of your final grade.

- (2) <u>Assignments (50% total)</u>. A total of ten (10) out-of-class assignments will be given in the course. Each assignment follows the in-class activity for that week and is individually weighted based upon the relative amount of out-of-class work involved in completing the assignment. Assignments are due, in class, the following week. All assignments must adhere to APA format.
 - **Penalty:** If you fail to turn in an assignment on time, or you turn in an incomplete assignment, you will incur an automatic 25% deduction of your grade on that assignment. Assignments turned in more than 24 hours late will receive an automatic grade of 0%.
- (3) <u>Take-home Final Exam (20% total)</u>. The take-home final exam consists of two (2) conceptual research questions (10% each) that require students to integrate their knowledge from the course material as a whole. Exam questions and instructions will be distributed and discussed in the last class meeting on April 10, 2014. Exam submissions must adhere to APA format. **Penalty:** If you fail to turn in the take-home final exam to the course dropbox by Thursday, April 24
- at 5:00 pm, or you turn in a partially completed exam, you will receive an automatic grade of 0 (zero) for 20% of your final grade.
- NB. Make-up Quizzes and Late Submissions: Supporting documentation must be provided for any request for extensions to assignments or missed quizzes. Should you find yourself in an extreme situation, please contact your instructors ASAP via email so that we may assist you. Otherwise, penalties will be levied as described above. There will be no opportunity to re-weight other course components or complete extra work to offset missed quizzes, late assignments, or poor performance. All written assignments and the final exam will be graded under the assumption that students have read and understood the contents of Northey and Timney (2012); specifically here, Chapter 2 Ethical Issues in Research and Writing. All assignments must be in your own words. Paraphrasing someone else's words or ideas, even if you reference those words, is plagiarism. Plagiarism is a serious academic offense. Any case of plagiarism will be dealt with severely, including the imposition of the maximum penalties allowable (see Part 4, Section 5 of the U of L Calendar regarding Academic Offenses).
