Prerequisite(s), Corequisite(s), and Recommended Background	Some Professional Diploma in Accounting courses have prerequisite, corequisite and/or recommended background requirements that are above and beyond the 10 courses in the program. Completion of this program may take more than one year of study. Students are responsible for ensuring they have these necessary requirements. Check prerequisites and corequisites in the current Academic Calendar or Timetable under View Catalog Entry for each course before registering. Students without appropriate prereqs or coreqs may be prevented from registration or removed from the course without notice.
Residence Requirement	Students must complete a minimum of five courses towards the Professional Diploma in Accounting at the University of Lethbridge. In addition, students must complete five of the following courses at the University of Lethbridge: MGT 3100, MGT 3101, MGT 3130, MGT 3131, MGT 3151, MGT 3160, MGT 3170, MGT 3180, MGT 4110, MGT 4130, MGT 4151, MGT 4160.
Time Limit	All Professional Diploma in Accounting requirements must be completed within five years after acceptance into the Dhillon School of Business.
Minimum Grade Requirement	A minimum grade of 'C-' is required in all Management courses to meet Professional Diploma in Accounting requirements. It is important to note that professional bodies (CPA) have their own minimum grade requirements. For further information, please contact an academic advisor or professional body representative.
